Part A: Pupil premium strategy plan

Statement of intent

We aim to provide an ambitious, innovative and stimulating curriculum for all disadvantaged students. High academic attainment and the development of widely-educated, confident and responsible young people are the twin aims of our curriculum. It is tailored to be academically challenging for our pupil premium students, the vast majority of whom study A Levels before beginning university degrees or degree-level apprenticeships.

All our students, including those who are disadvantaged, follow a balanced academic curriculum with the English Baccalaureate at its heart. We prioritise student choice to give each individual the opportunity to proceed to destinations that meet their interests and aspirations. This results in a broad curriculum and smaller examination set sizes than is typical in state schools nationally. Our aim is that Pupil Premium students make greater than expected levels of progress during their Education at the school.

Our curriculum aims to prepare students for a rapidly changing world whilst understanding and learning the best that has been thought, said and written. We promote and recognise success in a wide range of extra-curricular activities to enable students to discover and develop lifelong interests and talents. We ensuring that Pupil Premium students can access this rich set of experiences which develops students' strength of character and enables them to become empathetic, resilient and independent.

Challenges

Total budgeted cost: £20000

This will be spent on:

- Payment of residential trips for students in Years 7,8 and 9 who are disadvantaged
- Payment of Activities Week trips for students in Years 7
- Provision of IT equipment for disadvantaged students who join Year 7
- Payment of individual music lessons for students in Year 7 who are disadvantaged
- Bespoke support for individuals, dependent on need and as recommended by Heads of Department or Heads of School e.g. uniform, extra-curricular trips and visits, IT equipment
- Individual careers interviews for disadvantaged students in Years 9-11
- Supporting individuals during the External Examination Review Process by identification of those students who may benefit from a marking review and covering these costs for the student
- School counsellor costs, where necessary, for disadvantaged students

Pupil premium strategy outcomes
